Rules and Regulations

1. Contest is open for children aged 5 – 12 years old as of 31 Dec 2017.
2. Contestants must be amateur singers or entertainers, otherwise be persons who may be involved within the entertainment industry as singers or entertainers on a part-time basis, and do not belong to any professional organization (s) connected with the entertainment industry. Vocal contestants must not have any albums of any kind out in public.
3. Entries for the contest must be received by the due date and are subject to time availability of openings remaining. Anyone registering after due date may not have a chance to compete due to time slot availability.
4. The Organizer reserves the right at any time to require proof of identity and/or eligibility. Failure to provide such proof within a reasonable time could result in disqualification from the competition. All personal details and information requested by The Organizer by each contestant must be truthful, accurate and in no way misleading. The Organizer reserves the discretion to investigate and disqualify any contestant, should the contestant at any stage of the event supply untruthful, inaccurate or misleading personal details and/or information or should the contestant be ineligible for the competition pursuant to these rules.
5. By submission of an application and entering into this contest, each contestant represents and warrants his or her compliance with these rules and regulations. No contestant will be permitted to audition or participate unless he or she has acknowledged and agreed to these rules and regulations.
6. By entering, each contestant agrees that The Organizer and their successors have the right to use their names, likenesses, and images of all persons performing for future advertising, promotion and publicity in any manner and in any medium now known or hereafter devised in perpetuity.
7. Contestants must perform as a solo act or as a group of minimum 1 parent and 1 child for the Family Category.
8. Contestants MAY NOT utilize live props, back-up singers, dancers or animals. Nonhuman props such as costumes and other accessories are permitted. Contestants may accompany themselves or have one accompaniment of a live musical instrument.
9. Contestants must supply their own background tracks on a single CD. For vocal contestants, background music must be clear of lead vocal singers, only musical band instruments are acceptable.
10. Contestants are not permitted to leave the stage or stage area during their performance. This includes singing or dancing within the audience.

11. The time limit for each contestant is no more than 2 minutes for the Qualifiers and 10 minutes for the changing of music tracks will be allowed. Songs going over the time limit will be cut off.
12. Contestants may sing the same song as another contestant or group.
13. Contestants may dance to the same songs as another contestant or group.
14. No changes in song choice may be made once the contestant has delivered the background CD to the sound person. CD's must be given to the sound person 30 minutes prior to the start of the contest. For the sake of the other contestants and keeping the flow of the contest in order, please be available to perform one hour prior to your performance time. If not, you could forfeit your turn and possibly be disqualified. Also, when entering and exiting the stage, please be prompt.
15. Songs containing vulgar or explicit sexual lyrics will not be allowed. Contestants who during their performance, use any obscene, offensive, sexual or otherwise inappropriate behavior or gestures, including without limitation those referencing or depicting violence, nudity or explicit activity or which are not in the spirit of the contest or do not meet the The Organizer standards for any reason, as determined by The Organizer will be disqualified from the competition.
16. Contestants and/or their family or associates are not allowed to have contact with any contest judge before or during the competition. Please do not hang out in back of or around the judge's area.
17. Contestants and/or their family or associates who exhibit offensive behavior during any portion of the competition may result in the disqualification of the contestant from further competition. Offensive behavior includes poor sportsmanship, bad manners and lack of decorum.
18. The order in which each contestant competes in the Finals shall be determined by a random drawing.
19. In the event there is a tie, the contestants will compete for the award against each other. The vocal performers will each sing a song again. It is ONLY at this time that contestants may sing one of the same songs again or may repeat a song. This same rule applies to the dance performers. The same dance can be repeated from the night. Performers can perform a difference song or dance; it is up to the contestant. All the other same rules and regulations apply. One judge will be replaced with a new judge during the tie breaker round.

Judging for Solo Categories:

Contestants are to prepare **ONE** song/dance item of not more than **2 minutes** for the Qualifiers and **TWO** song/dance item of not more than **10 minutes** for the Finals.

Points system for Qualifiers and Finals are the same.

Judging for Family Category:

Contestants are to prepare **ONE** song/dance item of not more than **2 minutes** for the Qualifiers and **ONE** song/dance item of not more than **10 minutes** for the Finals.

Points system for Qualifiers and Finals are the same.
