Have Fun, Swim Safe



## INTRODUCTION

SwimSafer is a new national water safety programme introduced by the National Water Safety Council (NWSC) in July 2010, which combines both the National Survival Swimming Award (NASSA) and the Learn-To-Swim Programme (LTSP) into a progressive six-stage programme.

At the end of each stage, each child will receive a stage completion certificate indicating his/her individual skill achievements.

*Singapore Swimming Club will be offering stages 4 - 6 (Bronze, Silver and Gold) of the SwimSafer Program.*

## The pre-requisites are as follows:

### Stage 4 - Bronze Award

- Participant **must be able to swim without goggles**, and **swim at least 25m** in all three strokes, **front crawl, breaststroke and backstroke** (L3 and Above).

### Stage 5 - Silver Award

- Participant **must be able to swim without goggles**, swim at least **50m** in all 3 strokes; **front crawl, breaststroke and backstroke, and 10m dolphin kicks** (L4 and Above).
- Participant must have attained the Bronze Award

### Stage 6 - Gold Award

- Participant **must be able to swim without goggles** and at least **100m** in all three strokes; **front crawl, breaststroke and backstroke, and 15m butterfly** (L4 and Above).
- Participant must have attained the Silver Award

Each successful participant will receive a collar pin, woven badge and certificate approximately ONE month after the test.
